4. Purpose of processing personal data / use of data file	Data is gathered on the shareholders who have registered to attend the Annual General Meeting. The data is also received and recorded by the Elisa logging service.

5. Data content of the file	<p>If shareholders register in advance over the internet, Euroclear Finland Ltd provides the technical data collection solution. The data link from the user's browser to the Euroclear Finland Ltd server is encrypted using SSL. This service can be used to collect the following user data:</p> <ul style="list-style-type: none">– name, personal identity code, address, telephone number, email address, number of the user's book-entry account, number of shares and votes <p>The number of the book-entry account is only used for identification purposes within the Euroclear Finland Ltd system and it is not passed on to the company.</p>

6. Regular sources of data	<p>When registering over the internet the person enters his or her own data. Using the personal identity code submitted, the system compares the submitted data to the shareholder register maintained by Euroclear Finland Ltd and extracts the ownership data of the registered person from the shareholder register. If authorising another person to act on his or her behalf, the person also enters the personal data required for the proxy.</p>
